## **Documents circulation**



- 1. Documents are drafted and matured by SAG and ESA
- 2. Public Review:
  - the public review of SAVOIR documents are limited to member states
  - the public review will be done using the ECSS system
- 3. After public review documents are updated and approved
  - the approved SAVOIR documents will be available also outside the ESA member states, with traced distribution:
  - to be registered, a verifiable e-mail address of a valid company is required (excluding gmail, yahoo, etc.)
  - the approved SAVOIR documents are distributed via the ESA SAVOIR Document & Open Source Software repository (to be presented tomorrow)

# **Documents usage policy (2/2)**



General recommendation:

- quote SAVOIR documents rather than rewrite requirements.
- If modified, identify & trace modifications
- acknowledge SAVOIR copyright, clearly identify the document together with exact reference/version.

In ESA projects, SAVOIR docs will be part of project specifications:

- SAVOIR documents are intended to become Applicable Documents in ITTs, after a potential tailoring
- The tailoring shall provide the reasons of the modifications or the non application of requirements.
- This will allow to update the documents and adapt them to effective needs.
- Availability of a DOORS database is planned for SAVOIR documents



### **Review process**



- Agreement with Eurospace & ECSS has been reached to use their infrastructure for the public review.
- The public review follows the ECSS scheme for such reviews
- First batch ready for public review is (Nov-2014)
  - 1) SAVOIR Reference Functional Architecture
  - 2) SAVOIR generic OBC Spec
  - 3) Flight Computer Initialisation Sequence (Sw Spec)
- A second batch of doc's are ready for an internal review and should go for public review Q1-2015
  - RTU front-end spec
  - Software reference architecture
  - Component model
  - Execution platform
